1. Introduction

Your privacy is very important to me. This Privacy Policy explains how I collect, use, store, and protect your personal information in accordance with the **General Data Protection Regulation (EU) 2016/679 (GDPR)** and **Irish data protection law**.

2. Who I Am

I am a self-employed therapist operating in private practice in Ireland. I provide confidential psychological therapy to children and young people (age 7-18) and adult clients (age 18+). I am the data controller for the personal information I collect.

3. What Personal Data I Collect

I may collect and process the following types of data:

- Contact details (e.g. name, phone number, email address)
- **General personal information** (e.g. age, gender, GP contact, emergency contact)
- Health and therapy-related information (session notes, presenting issues)
- Payment or invoicing details
- Website data (e.g. IP address, cookies see Cookie Policy)

4. How I Collect Your Data

- When you contact me via my website, email, or phone
- During our sessions
- Through third-party referrals (if applicable and with your consent)
- From your use of my **website** (see Cookie Policy below)



5. Why I Collect Your Data (Legal Bases)

6. How I Use and Store Your Data

- Data is stored securely on encrypted, password-protected devices and/or GDPRcompliant cloud services.
- Session notes are stored separately from identifying information.
- Emails are stored securely and periodically deleted.
- I do not use your data for marketing.

7. Sharing Your Data

Your data will be kept confidential. However, I may share data in the following limited circumstances:

- With your **explicit consent**
- If required by **law or court order**
- If there is a risk of serious harm to you or others
- With my **supervisor** (anonymised) as part of professional standards
- With service providers (e.g. practice management software or accounting) who are GDPR-compliant



8. How Long I Keep Your Data

- Client records (including notes): **7 years** after the end of therapy (or as required by law/insurer)
- Emails and contact form enquiries: 6–12 months
- Financial records: 6 years (Revenue compliance)
- Website data (cookies): See Cookie Policy

9. Your Rights

Under GDPR, you have the right to:

- Access your data
- Rectify inaccurate data
- Erase your data (in some cases)
- Restrict processing
- Data portability (request a copy in a portable format)
- Object to processing
